## Flagstone Favourites People's Choice Awards - Public Voting Competition (Promotion)

#### **Terms and Conditions**

#### 1. Promotion Details

- 1.1 Entry into this Promotion is deemed acceptance of these terms and conditions.
- 1.2 The Promotion is a game of chance.
- 1.3 The promoter is Peet Flagstone City Pty Ltd ACN 151 187 594 of Level 3, 167 Eagle Street, Brisbane, Queensland, 4000 (**Promoter**).
- 1.4 Entry into this Promotion is only open to Eligible Persons.

- 1.6 The Promotion commences at 9.00am (AEST) on 17 June 2024 and concludes at 5.00pm (AEST) on 28 July 2024 (**Promotion Period**). The Promoter may extend the Promotion Period at its sole discretion (**Extended Promotion Period**). Details of any Extended Promotion Period will be posted on the Promotion Website. References in these terms and conditions to the Promotion Period include any Extended Promotion Period, where applicable.
- 1.7 The Promotion is only valid during the Promotion Period. The Promotion details set out in these terms and conditions are correct at the time of their first publication but may change at the Promoter's absolute discretion at any time. The Promoter will post any changes to the Promotion details (including these terms and conditions) on the Entry Website. Each Entrant should check the Entry Website at the time of submitting an Entry.
- 1.8 No late Entries will be accepted. The Promoter accepts no responsibility for any late, lost or misdirected Entries.
- 1.9 Specific eligibility criteria and terms and conditions for the Promotion apply, as set out below in these terms and conditions.

# 2. Eligibility Criteria

- 2.1 Subject to these terms and conditions, an Eligible Person who:
  - (a) during the Promotion Period, participates in the Promotion by submitting an Entry (**Entrant**) and satisfies the Eligibility Criteria; and
  - (b) otherwise satisfies these terms and conditions,

(Eligible Entrant) will be entered into the Prize Draw for a chance to win the Prize.

- 2.2 To be eligible for the Promotion and to go in the Prize Draw, an Eligible Person must within the Promotion Period, visit the Entry Website and:
  - (a) complete the online entry form by completing the Eligible Person's:

- (i) first and last name;

- (c) at the option of the Eligible Person, completing a short description about why the Eligible Person has voted for the relevant Nominated Business in the relevant Eligible Category; and
- (d) submit the completed online entry form,

## (Eligibility Criteria).

### 2.3 An Entrant:

- (a) must submit an Entry which votes for at least one Eligible Category to be entered into the Prize Draw; and
- (b) may submit an Entry which votes for more than one Eligible Category.
- 2.4 The Entry by an Eligible Entrant will become one (1) Entry into the Prize Draw. An Eligible Entrant is only entitled to one (1) Entry into the Prize Draw. Any additional Entries from the same person will be deemed invalid.
- 2.5 The Promoter will not include an Entry in the Prize Draw that does not satisfy the Eligibility Criteria.
- 2.6 It is each Entrant's responsibility to ensure their Entry is valid and is received by the Promoter by the end of the Promotion Period.
- 2.7 The Promoter reserves its right, at any time, to verify the validity of Entries and Entrants (including an Entrant's identity and place of residence) and to disqualify any Entrant who submits an Entry which is not in accordance with these terms and conditions or who tampers with the entry process.
- 2.8 Any purported Entry which:
  - (a) contains content which, in the sole opinion of the Promoter is inappropriate or objectionable, including but not limited to content containing profanity or insulting, inflammatory or defamatory statements or generally intended to damage the reputation of the Promoter or any Nominated Business;
  - (b) is not submitted in accordance with these terms and conditions;
  - (c) does not satisfy the Eligibility Criteria; or

(d) is submitted in a manner which is misleading or deceptive, or fraudulent, will not entitle the Entrant to an entry in the Promotion or the Prize Draw or to win the

#### 3. Details of the Prize

Prize.

- 3.1 The total prize pool is AUD \$1,000.00, being the retail value of the Prize.
- 3.2 The Prize is not redeemable for cash and is not transferable.
- 3.3 The Winning Eligible Entrant must collect the Prize from the Promoter's 'Flagstone Sales and Information Centre' located at 224 Flagstonian Drive, Flagstone, Queensland during opening hours. - 3.6 Neither the Promoter nor its related entities will be liable to replace, reissue or reimburse the Winning Eligible Entrant for any remaining dollar value on the Prize which is expired, defaced, stolen, damaged, lost, altered or otherwise damaged or tampered with in any way.
- 3.7 The Promoter reserves its right, at any time, to make a cash payment in lieu of the Prize or any part thereof provided that the total amount is at least AUD \$1,000.00.

#### 4. Details of the Prize Draw

- 4.1 One (1) winner will be awarded the Prize.
- 4.2 In relation to the Entries that meet the Eligibility Criteria, the Promoter will conduct a random draw to select the Prize winner at 10.00am (AEST) on Monday 5 August 2024 at 224 Flagstonian Drive, Flagstone, Queensland, 4285 (**Prize Draw**). The Eligible Entrants do not need to be present at the Prize Draw to be eligible for the Prize.
- 4.3 The Prize Draw is determined by chance and each Eligible Entrant who has satisfied the Eligibility Criteria has an equal chance of winning.
- 4.4 Subject to clause 4.5, the first Eligible Entrant drawn in the Prize Draw will be declared the winner (**Winning Eligible Entrant**) and will win the Prize.
- 4.5 If the Winning Eligible Entrant:
  - (a) cannot be contacted;

- (b) cannot prove they are an Eligible Person; or
- (c) does not claim their Prize,

within fifteen (15) Business Days after:

- (i) the Prize Draw, the Winning Eligible Entrant will forfeit their Prize and the Promoter will conduct a re-draw for the Prize from the remaining Entries submitted by Eligible Entrants within two (2) Business Days after the forfeit and a new winner for the forfeited unclaimed Prize will be announced (and will therefore become the Winning Eligible Entrant). If this occurs, the original winner has no claim to the Prize and no recourse against the Promoter; and
- (ii) a re-draw, the Winning Eligible Entrant will forfeit their Prize and the Promoter will conduct a re-draw for that Prize from the remaining Entries submitted by Eligible Entrants within two (2) Business Days after the forfeit and a new winner for the forfeited unclaimed Prize will be announced (and will therefore become the Winning Eligible Entrant). If this occurs, the first redraw winner has no claim to the Prize and no recourse against the Promoter.
- 4.6 The process in clause 4.5 will continue for the Prize until a Winning Eligible Entrant validly claims the Prize.
- 4.7 An Eligible Entrant who has been drawn as a Winning Eligible Entrant in a Prize Draw or a re-draw is not eligible to win the Promotion through any subsequent re-draw and will be excluded from any re-draw.
- 4.8 The Winning Eligible Entrant may be required to verify their eligibility (such as confirming they are an Eligible Person) before claiming the Prize.
- 4.9 The Winning Eligible Entrant will be notified by email between Monday 5 August 2024 and Monday 12 August 2024. In the event of a re-draw, the Winning Eligible Entrant will be notified by email within 2 Business Days after the re-draw.
- 4.10 The Promoter will deliver the Prize to the Winning Eligible Entrant (who has validly claimed the Prize) within one month after the Prize Draw, or in the event of a re-draw, within one month after the date of the re-draw, pursuant to clause 3.3.
- 4.11 The results of the Prize Draw and any re-draw will be published on the Promotor's website and may also be published on the Promoter's Facebook page, in Flagstone Focus, a community electronic direct marketing communication and by media release.

# 5. Participating details

5.1 The Promoter accepts no responsibility for late, lost, incomplete, incorrectly submitted, delayed, illegible, corrupted or misdirected Entries, claims or correspondence whether due to error, omission, alteration, tampering, deletion, theft, destruction, transmission interruption, communications failure or otherwise. The Promoter has no control over

communications networks or services, the internet, or computer or telephone networks or lines and accepts no responsibility for any problems associated with them, whether due to traffic congestion, technical malfunction or otherwise. The Promotor is not liable for any consequences of user error including (without limitation) costs incurred. Any form of automated entry using any device or software is invalid.

- 5.2 All Entries and materials submitted to the Promoter in connection with this Promotion (in any form, including without limitation in hard copy or electronic form), become the property of the Promotor and each Entrant and Eligible Entrant warrants that it has the right to transfer these things to the Promoter. ### 6. Other terms and conditions

- 6.2 In the event of any dispute as to eligibility to participate in the Promotion, eligibility will be determined by the Promoter, acting reasonably, and the Promoter's decision will be final and binding.
- 6.3 To the extent permitted by law, neither the Promoter nor any of its employees, agents or officers will be liable for any loss, damage or personal injury suffered or incurred by any person arising from or in any way related to the Promotion or the Prize.
- The Promoter may cancel or make changes to the Promotion at any time without notice, including shortening or extending the Promotion Period.
- 6.5 These terms and conditions supersede any prior terms and conditions for the Promotion.
