# Newhaven solar offer.

## Inclusions

The offer will include a contribution of up to \$3,500\* towards the provision of a 3kW solar energy system including solar panels and a solar inverter. Please note, any cost incurred above \$3,500 will be the responsibility of the purchaser.

## Size and Orientation

Each solar panel is approximately 1.65 square metres. A 3kW system will require around 10-12 solar panel modules which equates to approximately 18sqm of roof area.

It is recommended that the panels are north or west facing where possible. North facing panels will generate a higher kWh production output but for a shorter period of time, whereas a west facing panel will have a lower kWh output (18% less than north facing) but will allow for longer and more sustained energy production.

## Equipment

Inverters convert the direct current from the sun into electricity that can be used for your home. Inverters can also provide data usage and output monitoring, and controls to ensure that it can operate at an optimal performance level.

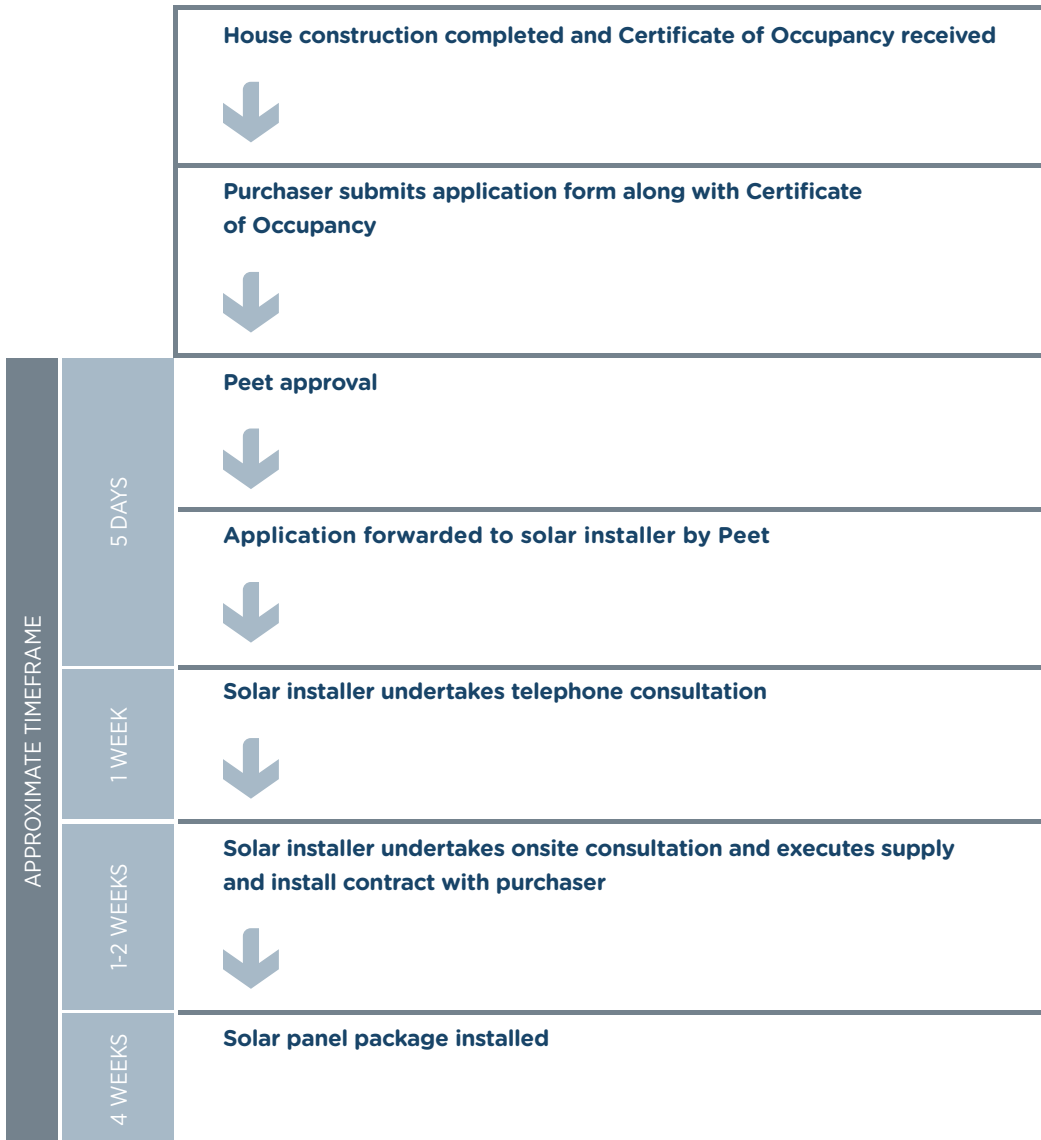
## The Offer
