- Peet will confirm receiving your application via email and will forward your details to the appropriate contractors.
- The contractors will make contact with you (usually by email in the first instance) and liaise with you directly to make the installation arrangements.

Before Fencing Installation

- As part of the restrictive covenants and to comply with the terms and conditions of your fencing and landscaping package, all house plans need to be submitted for Peet's approval prior to commencing construction.
- Ensure you remove all rubbish and rubble and the area is leveled and ready to be fenced.
- Ensure your survey pegs are still in place and that paving is done after the fencing has been completed, as this will not be reinstalled by the fencing contractors.

Please note, to be eligible for the Fencing Bonus your house must be complete within 24 months of settlement, you must be the original purchaser of the Lot and this form must be forwarded to Peet within 2 months of occupation of the house.
